

◆ **APPLICATION PROCESSING PROCEDURE:**

All new REALTOR® applicants must call the Association office, 253-0028, to schedule an appointment with the Director of Member Services for the processing of their application in order to be granted provisional membership immediately upon submission of all completed application forms and fees. Provisional members shall be considered REALTORS® and shall be subject to all of the same privileges and obligations of membership, however, membership is granted subject to approval of the Board of Directors (BOD). If the BOD determines that the individual does not meet all the qualifications for membership as established in the Association's bylaws, or, if the individual does not satisfy all of the requirements of membership (for example, completion of a mandatory Orientation program) within (120) days from the Association's receipt of application, membership may, at the discretion of the Board of Directors, be terminated.

NOTE: Each application must contain: 1) a copy of your current real estate/appraiser license 2) a "Dues Payment Verification" form if applying for secondary membership or transferring your Primary membership from another Association and a completed New Member Orientation registration form. Checks should be made payable to WAAR and returned to the Director of Member Services, Cindy Homewood.

◆ **NEW MEMBER ORIENTATION:**

Membership applications will be processed as quickly as possible, however, as mentioned above provisional membership allows applicants to advertise themselves as REALTORS® and begin receipt of services upon submission of the membership application and payment of dues. To finalize your REALTOR® membership you must complete the New Member Orientation Program within 120 days of your application date or your provisional membership may be revoked and your membership dues forfeited. Reminder: The completion of the attached New Member Orientation registration form is required and cancellation may incur a \$35 rescheduling fee.

Below is a list of the currently scheduled New Member Orientation Programs. You are expected to attend the next scheduled course unless you notify Association staff of a conflict. Each course is scheduled for two consecutive days from 8:30 a.m.—12:30 p.m each day.

I understand that I will be required to complete Quadrennial Code of Ethics training as specified in the Association's bylaws as a continued condition of membership. **NOTE: Applicant acknowledges that if accepted as a member and he/she subsequently resigns from the Association or otherwise causes membership to terminate with an ethics complaint pending, the Board of Directors may condition renewal of membership upon applicant's certification that he/she will submit to the pending ethics proceeding and will abide by the decision of the hearing panel. If applicant resigns or otherwise causes membership to terminate, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while applicant was a REALTOR®**
